### **General Overview**

California sales tax receipts increased by 7.3% over the same quarter from last year, with Northern California reporting a 6.9% increase compared to a 7.6% increase for Southern California. Sales tax receipts for the City of Turlock increased by 4.3% over the same period. Most of the increase in the City of Turlock was in the Heavy Industry, Auto Sales New and Service Stations. Furniture/Appliance and Food Markets also had some gains.

**GDP:** Grew 2.6% in 2018Q4: 3.4% in 2018Q3; and 4.2% in 2018Q2. Consumer spending was robust due to a strong job market, tax cuts and household income gains. Business investment, after faltering in the third quarter, bounced back in final three months of the year.

The California Department of Tax and Fee Administration announced that it will require out-of-state retailers to collect and remit use tax beginning on April 1, 2019 if in the preceding or current calendar year their sales into California exceed \$100,000,or 200 or more separate transactions.

#### Real Estate Sales in California:

Statewide sales of existing, single-family homes in January 2019 totaled 357,730, down 3.9% from December and down 12.6% from January 2018. The 30-year, fixed-mortgage interest rate averaged 4.46% in January, up from 4.03% in January 2018 (Freddie Mac).






