Project Specifications:

**1. Section 00 30 00, "BID FORM" is amended to read as follows:**

Remove and replace the bid form located on page 00 30 00-2 with the attached bid form.

**Note to bidders regarding the above change:**

With this Addendum No. 1, a bid item is added to the bid form consisting of an allowance for additional work related to the access control system. A complete access control system was installed for the previous phase of the transit center building, however, access control components such as card readers, motion detectors, alarm keypads, etc. are not included in the scope of work of the subject project. The project plans shows these missing components as being installed "by others." The City desires that the subject project include all work necessary to provide access control components that expand upon the existing system procured under the previous phase of work. Therefore, an allowance is hereby added to provide additional budget to compensate the contractor for the work necessary to achieve this goal. It is estimated that full design details regarding the additional access control work will be available in mid-April 2019. After this design work has been completed, the City will issue a contract change directive to the awarded contractor to add the additional scope of work to the project. The allowance added with this Addendum No. 1 shall be utilized to compensate the contractor for the additional work needed. Bidders are referred to Part 3.8 "Allowances" of Section 01 00 00, "General Conditions" of the Specifications for more information regarding contract allowances.
