SUPERVISOR COMMENTS

Calls for service were steady throughout our shift. Shortly after briefing a hit and run traffic accident was reported with a witness following the suspect. Officers responded to the scene quickly but the witness lost sight of the suspect and the suspect vehicle. A short time later, an officer located the vehicle abandoned. Through the course of our investigation we were able to identify a suspect. The suspect ultimately came to the police department to provide a statement and admitted to the crime. He was arrested and later booked into jail. We received the report of a subject armed with a rifle in the area of Fifth St. and D St. Officers responded to the scene and were unable to locate the subject due to a lack of information provided by the witness. Officers later located the subject and the weapon that turned out to be a BB gun.
