SUPERVISOR COMMENTS

An officer made a traffic stop and contacted a male driver who verbally identified himself with his brother's identity. Through investigation officers were able to determine the driver's real name and found that he had three warrants for his arrest, one being a felony. He was arrested and booked for the warrants and identity theft. Another officer made a traffic stop and contacted the driver. The driver was displaying signs of intoxication, had a suspended license for prior DUI's, and was on probation. He was non-compliant with the officers and would not place his hands behind his back when he was told he was under arrest. The officer utilized a take-down in order to get the male in custody. His breath analysis showed he was over .08 BAC and was arrested/booked for DUI and resisting arrest. Officers also responded to a disturbance in-progress at an apartment complex. On arrival officers saw a male trying to force his way into an apartment. The male tried to walk away from officers but was quickly detained. The investigation revealed the male had gone over looking for his ex-girlfriend. The mother of the girl opened the door at which time the male forced his way inside and began to assault her and damage property inside and outside of the apartment, while threatening to kill her. He was arrested and booked for burglary, assault and battery, and criminal threats.
