#### SUPERVISOR COMMENTS

Night shift responded to multiple incidents, two of them resulted in the arrests of subjects. Officers responded to a disturbance between a male and a female. During the investigation it was determined the male had assaulted the female. He was arrested and booked into jail for domestic violence related charges. Officers responded a female walking around a neighborhood knocking on doors. Officers located the female who was laying down next to a bush. The female was severely injured. Officers learned that the female had been held and assaulted by her husband throughout the day. The female was transported to an area hospital for treatment to her injuries. The suspect was contained inside of residence and surround/ callout process began. After a while, the suspect exited the residence holding an improvised impact weapon over his head. He then threw it at officers and struck a patrol vehicle. Less lethal tools were deployed and the suspect surrendered being placed under arrest. TPD Detectives responded to assist in the investigation. The suspect was taken to an area hospital for clearance. Upon being cleared he will be booked into jail for 7 felonies and 1 misdemeanor, one of the felonies being attempted homicide. This incident took several hours and was resolved in a safe manner due to the team work of all shifts involved.
