SUPERVISOR COMMENTS

Officers responded to a security check after a female called police to report her boyfriend hit her. The female hung up on dispatch and did not provide any further details. When officers arrived at the location a male took off running from officers. A perimeter was set up and the drone was utilized but the male was not located. Additionally, the female had left the residence before police arrived and left her cell phone behind. We were unable to locate either party to further investigate the call. An officer contacted a group of people outside of a closed business. One of the subjects had warrants and was arrested. An officer also witnessed a vehicle swerving on the roadway and made a traffic stop. The driver was determined to be driving under the influence of alcohol and had a suspended license for prior DUIs. He had a BAC over .08 and was taken to jail for DWI.
