SUPERVISOR COMMENTS

Busy day with calls pending all day and officers trying to keep up. We were short-handed for a bit with one officer in court this morning. Officers responded to a call of a male and female walking downtown with the male swinging around a small gun. They were located and found to have a BB gun and drugs in their possession. The male gave a false name knowing he had warrants for his arrest out of Livingston and Madera, but it didn't work out for him. The female was cited for drug possession and the male was booked. A male was contacted by an officer for camping in a park. He refused to give his name, then presented a false ID card. This didn't work out for him either. He was holding his real ID card in his hand. He had warrants out of Merced for resisting arrest and violation of a court order. He refused to walk to the patrol car after being arrested so he had to be placed in the WRAP restraint device and carried to the car. This afternoon, officers responded to a vandalism where an adult male was drunk and damaged his parent's vehicle with a rock. He was arrested for felony vandalism and then found to have cocaine in his possession also. He was booked for the vandalism and drug charges.

SUPERVISOR COMMENTS

It was a busy shift; Calls for service type included vehicle accidents, assault & battery, court order violations, larcenies, and warrant arrests. Several in-custody reports were taken: A male went into a shoe store and stole two pairs of shoes. He was found leaving the area by officers and arrested. He also had warrants and was on probation for theft with priors. Officers responded to a domestic dispute and a woman was arrested after she struck her husband several times in the face during an argument, leaving him with injuries. Officers also responded to a court order violation in-progress involving an elder abuse victim and her son who is restrained from her. He was arrested by officers and booked into jail. Officers also made numerous self-initiated stops resulting in some warrant and narcotic related arrests.

SUPERVISOR COMMENTS

Officers had a relatively slow shift, allowing them to catch up on reports and conduct proactive patrols. Officers also assisted Merced Police Department with an aggravated assault victim that was brought into Emanuel Medical Center. Due to the severity of the injuries Merced Police Department elected to respond to the hospital. Turlock Officers remained with the victim until Merced Officers could arrive and take over the investigation.
