SUPERVISOR COMMENTS

Officers responded to a security check of two young children who reported to be living in a vehicle with their mother. One of the children showed severe signs of neglect, including a vaginal rash from sitting in a soaked diaper for days. The children smelled of cigarette and one child had a cigarette burn mark on the arm. CPS was notified and an emergency protective order was granted by a judge before the mother was arrested for juvenile abuse. The children were given to the father, due to no custody orders existing. Officers also responded to a suicidal person who was holding a kitchen knife to her arm. She had been arguing with her boyfriend, and their two-year-old child was in the apartment. Officers were able to get the knife away from the female and she was detained. The investigation revealed a domestic battery had occurred and she was the aggressor. She was arrested and booked into jail after being served with a protective order.
