**SUPERVISOR COMMENTS**

Very busy day right out of the chute. Officers had to clear from briefing a little after 6am, to handle a fight between a boyfriend and girlfriend on a sidewalk. It turns out their use of methamphetamine probably contributed to the fight this morning. When the dust settled, the female was booked for felony domestic battery and possession of meth. The male was on probation for auto theft. A search of his backpack revealed drugs, shaved keys commonly used to steal cars, and checks not belonging to him. He was booked for various drug and fraud charges. An officer recognized a male who was on searchable probation for narcotics charges. He was stopped, searched and found in possession of methamphetamine. He was booked for felony possession due to his prior convictions. An officer saw a male walking who he recognized as having a felony warrant. The male was arrested and booked. At the same time, another officer stopped two males on probation and found them to have drug and warrants. They were booked also. At one point, we had 3 prisoners needing to go north, so one officer took all 3 in the transport van. The jail refused one of the males due to low blood sugar, so he had to be medically cleared at the hospital prior to booking. This afternoon, a drunk female driver crashed into a light pole on Monte Vista, and then fled the scene on foot. She was located and arrested. She decided to try and kick out the window of our patrol car, so she was placed in the WRAP restraint device. She was transported to the hospital for a DUI blood draw and then to jail. She happened to already be on felony probation for DUI and child endangerment, so additional charges of felony violation of probation were added. Other than that, it was nice to see the sun come out today.

A DWI investigation was conducted and the subject was arrested and taken to the jail, after a blood sample was obtained at the hospital.
