**SUPERVISOR COMMENTS**

It was a busy night, with it also being the last shift before rotating. Four officers were on an overtime detail for a suspected large car meet/sideshow rumored to be in Turlock tonight. Several traffic stops were made near the Monte Vista Crossings, which showed a strong police presence in the area. During one traffic stop, the driver placed his vehicle in reverse, thinking it was in park, and rolled into the officer's patrol unit. Very minor damage was caused to the suspect's rear bumper. The driver was determined to be DUI and was arrested. Another officer was alerted of a stolen vehicle in the area. He located the vehicle at a gas station and two males were detained. The vehicle had been stolen out of Washington and the driver was arrested. Officers also responded to a disturbance at a downtown bar involving four intoxicated males. The males were gone before police arrived, but while checking the area for them, another call was received of a vehicle vandalism that just happened in the vicinity. Officers were quick to arrive and located the four males from the prior call. One of the males was so intoxicated, he decided to get into a fight with the windshield of a parked vehicle. He punched the windshield, and obtained a hand injury. He was identified by the witness/victim and placed under arrest for a felony amount of damage to the vehicle.
