



# Youth/Senior Recreation Scholarship Program

Recreation For All!

2020/2021

## General Information

The Recreation for All Scholarship Program is for any youth/senior individual wishing to participate in a City of Turlock Parks, Recreation & Public Facilities Department Program.

Approved applicants will be eligible for a maximum award of \$500.00 per fiscal year (July 1 – June 1) to be used as stated above. Recreation Scholarship will be granted to pay up to 90% (pending qualifications) of the registration fees for programs that cost \$30.00 and above. Participants will be required to pay the remaining percentage at the time of registration. Applications are considered July 1, 2020 through June 1, 2021. If approved funds must be used within a 3-month time period from application approval date. January 1<sup>st</sup> applications that have been approved will be reviewed. Those with an approval date older than three months and no funds used will be updated to the new income limits and applicants will be required to submit updated proof of income forms to qualify for any funds that are still available. Only one application per household.

## Eligibility Requirements

- Must live within the city limits of the City of Turlock (provide a copy of a utility bill along with a picture ID).
- Be 18 years of age or under or 62 years of age and above (**must provide birth certificate for each child/Senior**).

**Must also meet the following requirements:**

Show proof that the household income is at or below 80% of the current HUD guidelines (Current pay check stubs for last 2 months, unemployment, worker’s compensations, social security, state disability. If no income must provide a STATEMENT OF EARNED INCOME FROM SOCIAL SECURITY OFFICE or sign a DECLARATION OF NO INCOME STATEMENT FROM OUR OFFICE.).

- Applications that are incomplete or do not provide the appropriate information will not be accepted.
- Any unused funds by the applicant will be forfeited if not used by the expiration date.
- Money will be issued on a first-come, first-served basis as long as funds are available.
- Your application will be verified and processed in approximately 10 working days from the time it is received at the Parks, Recreation & Public Facilities office.
- Once the application is approved, applicant will be notified by phone and funds will be available to use on Recreation Activities.
