D. WORKSHOP ON THE FUTURE OF TURLOCK'S DOWNTOWN:

The workshop will focus on the future development and design of Turlock's downtown. This interactive workshop will feature presentations by the Local Government Commission (a nonprofit organization that assists local governments that are working to create healthy, walkable, and resource-efficient communities) and Stefan Pellegrini with Opticos Design. Residents and business owners can expect to learn more about the Downtown Design Guidelines and Zoning Regulations Update; envision how new development might look like in the downtown; provide feedback and ask questions; and share their own ideas for ensuring downtown remains a vital center of civic life in the City of Turlock.
