## H. OTHER MATTERS

 WORKSHOP ON RECREATIONAL VEHICLE PARKING IN RESIDENTIAL DISTRICTS: Staff will present a comparison of regulations adopted by various jurisdictions regarding standards for parking recreational vehicles, boats, and similar items in residential districts. The Planning Commission will provide comments to staff on potential amendments to the current regulations. No action will be taken on this item. (Quintero)

Senior Planner Katie Quintero explained in November 2016, the Planning Commission heard a public request to look at the allowance of recreation vehicle parking in the City of Turlock. The Commission asked staff to bring the item back at a

later date to discuss. Pictures of recreational vehicles around the City were shown. A presentation of other cities zoning ordinances showed a wide-range in standards. Staff requested clarifications on defining space, 72-hour limit in public right-of-way, as well as discussion on prohibition, front and side yard size limitations, and restrictions of vehicles allowed. Commissioners inquired about the number of complaints received; wanted a clearer understanding of the issues. Ms. Quintero will get a report of complaints for them. The Commissioners discussed setbacks from alleys, infringement on private property, enforcement of 72-hour parking in the public right-of-way, and other Cities findings. The Commission directed staff to bring back a definition of space, ideas for additional limitations on 72-hour parking and an additional requirement that recreational vehicles should be parked perpendicular to the right-of-way. The Commission was not interested in making major changes to the existing Ordinance at this time. This discussion will continue at a future date.
